Introduction to Printing (ID2)

COURSE OBJECTIVES:

On completion of this 2 day course, the candidate will have a good understanding of all the processes involved in producing a printed article. They will understand the pre press parameters within which an originator designs articles for printing. They will have a sound knowledge of the various printing processes and their suitability to producing different products and the methods of finishing these articles.

WHO SHOULD ATTEND THIS COURSE?

All new staff to the printing Industry, including sales consultants, brand managers and advertising agency staff. Print buyers and marketers from all industries benefit from this course which explains all the terms commonly used in the printing processes. Existing staff from companies can broaden their knowledge into other areas of print. This is also a compulsory module which must be completed by all learners in the printing Industry (ID 2).
